## **Minutes from 8/9/2020**

Minutes were reviewed. Motion was made to approve 8/9/2020 minutes by Chris Bennett and seconded by Lisa Eckam. All in favor.

## **Treasurer's Report:**

Chris Bennett reported we have collected \$72,582.65 in membership dues and \$1,018.75 in late fees for 2020. The expenses are \$61,140.49 paid to date. The school tax bill was paid for this year. There are three (3) members remaining who have not paid their dues for this year only. The total number of members who have not paid their dues for more than one year is ten (10). Penalties are now being applied to all late dues owed in the amount of 10%. Chris Bennett went to the county courthouse and cleared two (2) liens on properties whose past due dues were paid within the association.

Chris Bennett will once again investigate the association insurance costs by obtaining three (3) quotes at renewal time.

There was a motion to approve the Treasurer's Report made by Lisa Eckam and seconded by Steve Corey. All in favor

## **Roads Report:**

All is good with the roads. Tim Wurzer again repaired the roads disturbed by the torrential downpour.

## **Shoreline Report:**

A mailing was sent to the twenty (20) members who will need to move their docks/hoists. Tony has received six (6) responses to date from that mailing.

There are currently ten (10) members waiting for a slip space.

## **Parks and Recreation Report:**

No report.

Lisa Eckam reported members are still dumping garden waste in the park. The board discussed putting up a solar powered webcam pointed at the park to monitor who is putting the waste in the park. We also discussed the need to fine those caught dumping in the park. We agreed we will need to revise the dumping signs if we decide to fine those caught. Sharon Helbig will review the By Laws to ensure we are able to do this legally. She will also pass this by our legal counsel.

Joe and Lisa Eckam will provide topsoil from their front lawn to fill the major holes in the park area. We agreed this is needed so no member or guest steps in the large holes and injures themselves. We will fill the holes once the topsoil is dropped off and put down grass seed.

## **Website Report:**

Michael Philipson reported he posted the census information on the website and sent out an email to all members in order to ensure everyone fills it out. We have a large population in our association and want to support the county in getting everyone to complete the information.

## **Open Discussion:**

### **Flooding:**

Michael Philipson reported Rochester Street was badly flooded during the last torrential downpour. We discussed the need to start working on drainage on Rochester Street to help alleviate this issue during rain storms. We decided it would be best to tie this in with the shoreline restoration project so both get done at the same time.

The board also discussed looking into different road materials on the steeper streets to help alleviate the erosion during the rain storms.
