# **Open Discussion:**

Special Guest, Scott Biggars, had questions as to what the shoreline will look like after the restoration is completed. He expressed concerns about how the docks will rest on the new shoreline. Scott has removed his bench in front of his slip space but left the flag. Michael addressed the goal of the restoration and how docks are intended to rest on shore vs a deck. Scott also brought up concern for

#### **Shoreline Restoration:**

We are still in the process of working with Seawalls to obtain the permit from the DEC to begin restoration. Joe Eckam to contact Seawalls to get an estimated timeframe on starting this project and a quote for top soil. Joe also to investigate pipe extensions.

Tim Fess to talk to Michael's neighbor about the cost of hydro seeding once the project is complete. Tim also will talk with the Sewer Dept about staging for the restoration project.

There was a motion made by Michael Philipson to adjourn the meeting and it was seconded by Tim Fess. All in favor.
